# **General Business**

- 1. Gail thanks the committee for their work
  - Bruce work through covid with operational plans with time and effort thanks by Casey
  - Grant work through covid stuck In lockdown, leading building committee thanks by Casey
  - Jodie managing club bookings, meeting organisation, club website management and new website to be presented once complete(\$10,000 worth of website donated to the club) thanks by Casey
  - Jo Wood thanks Casey for her work as chairperson supported by meeting
  - Ruth hanner thanks Maiya for 5 years of work supported by meeting
- Jo Wood questioned building committee process answered by Casey with info on resource consent and project disrupted by covid and not biggest priority – surveyors visited club and architect/engineers employed – committee still there and managed as separate entity and run by facilities manager.

Helenne – asked about process of building committee – Mark – could rebuild here and talked about erosion risk and mentioned other clubs have tower close to shore and other buildings off shore – site has challenges and difficult to find funding for building that could disappear – could get resource consent but underlying erosion risk – since 2016 report the environmental risk has gotten worse(sea level rise, storm intensity)

Ruth – distance between gear shed and sand dune was less and someone rebuilt dunes which haven't collapsed

Gail – erosion stopped by planting projects – more focus on not playing on the dunes and proof that it worked as whiritoa one of first to plant and model was used in other places

Jo wood – people like current club in terms of bar and bar view and don't want to drink off the beach

3. Ross – club communications – focussed on social media and those who don't use it get no information – Casey replied with social media working well but need to expand to other forms of communication – (into the tidings, text message, discussing methods with other clubs).

- 7. Kane committee appoints an auditor at their discretion. Seconded Vicki
- 8. Older guards left to have children and will return once children come through junior surf and will come back together – Casey – shoulder tapping junior surf parents to help at club in any way as they unsure how to get involved
- 9. Vicki logo issue raised Casey with website upgrade was opportunity to refresh club brand which included logo committee worked through that process can refresh it or incorporating current logo into it Elaine raised she likes current logo seconded by Ruth
  - Lachlan thinking about changing logo got to respect passed guards who worked under current logo
  - Vicki loads of entities rebrand and listening to guards and way forward would be taken to new committee and canvas membership in formal matter – acknowledge current logo but should be raised – suggests further feedback that goes to new committee – Liz/Helenne – what is that opinion and informal vote of the room which has a selection of the community -supported by Gail/Casey and Casey asked room about new logo – unanimous support for old logo

  - Stella mentioned new logo with new club if time comes
  - Helenne logo so much more than a picture
  - Stella asked for logo background to see if it aligns with current club values committee talk to Dave East/Bill Goodwin
