No nominees from the floor so as per Constitution clause 9b(i) the Chairperson declared these candidates as elected to these positions.

Update of Club Constitution - Steve Wood

Thanks to those who responded to request for feedback on amendments. Last updated 2016. Proposed updates 2019 – appear to be have disrupted by Covid and never ratified.

New Incorporated Societies Act – Incorporated Societies not yet required to comply with new legislation but some updates are needed.

Some feedback suggested we could wait to see what other clubs and SLSNZ do and follow

their lead – SLSNZ not involved in individual clubs governance so unlikely to be helpful Other feedback noted.

A 75% majority of members present at meeting are required to change constitution

Acknowledgements to tangata whenua and of original writers and subsequent guardians of

constitution. Aim is for it to be a living document

No change to the 'spirit' of constitution

Changes:

Te Reo name of Club temporarily removed from this version while we re-engage

with iwi to check the correct wording

Membership consent required under new act

Honorary officers role descriptions – roles not currently filled.

Removal of non-attending committee member clause tidied up Major change is term of office for committee members – change to 3 year term. Risk of dysfunctional committee member, but there are means to resolve this. Aim is to reduce unnecessary committee turnover.

Inclusion of SLSNZ Patrol Support qualification to be equal as lifeguards President – preference given to candidate who is a current of previous guard

Questions:

Belinda Matheson– seeking clarification if president preference is for a current or previous Whiritoa guard or guard qualified elsewhere– Steve Wood: Club President candidate needs to be a current WLGS member but their guarding qualification/experience could have been obtained elsewhere. Vicky Carruthers – is it an SLSNZ requirement for the Club President to be a lifeguard? Ross McCullough: no not a requirement Vicki Skill: no SLSNZ engagement on club leadership – they only contribute to lifeguarding matters **Motion to accept changes to Constitution:**
